To All Servicing Carriers:

MASSACHUSETTS ASSIGNED RISK RATING PLAN (MARRP)

In an effort to facilitate the processing of policies for risks rated under the Massachusetts Assigned Risk Rating Plan (MARRP) who are also enrolled in the Qualified Loss Management Program (QLMP), the enclosed listing of qualified loss management firms and their respective credits is being provided so that servicing carriers can verify the credit amount indicated on the Certificate of Participation. Pursuant to previous instructions, this document is initiated by the qualified loss management firm at time of enrollment in the firm's program and is provided to the client company or its producer. The Certificate is then attached to the application for assignment, if new business, or the renewal documents to be submitted to the servicing carrier.

It should be noted that the credit is halved in the third year of participation in the QLMP.
