CIRCULAR LETTER NO. 2317

To Members and Subscribers of the WCRIBMA:

UNIT STATISTICAL REPORTING DATA QUALITY INCENTIVE PROGRAM

The Unit Statistical Reporting Data Quality Incentive Program (USDQIP) was announced in Circular Letter 2289. The program outlined that carriers will be notified at least 6 months in advance of any data quality edit becoming finable. All changes to finable data quality edits will be introduced either January 1 or July 1. Attached is the list of data quality edits that may be finable effective January 1, 2018.

The effective date for the USDQIP is January 1, 2017. There was an amnesty period for the first 6 months, January 1 – June 30, 2017. Starting with August 2017 invoice (for fines accrued in July 2017), invoice notices for carriers that accrue USRDQIP fines will be emailed monthly to carriers' USR contacts. Invoices can be viewed by using the Invoice Management Portal within the Secure Online Services Account (SOSA) area of the WCRIBMA's web site. Since the amnesty period has ended, invoices produced August 2017 and forward will be subject to collection.
