RE: GOVERNING COMMITTEE MEMBERSHIP: 2023-2024 TERM

RESPONSE REQUIRED BY DECEMBER 31, 2022

The member companies of the Workers' Compensation Rating and Inspection Bureau of Massachusetts (WCRIBMA) will be considering nominations for election to the Governing Committee for the 2023-2024 term at the June 1, 2023 Annual Meeting.

All WCRIBMA member companies are eligible for election to the WCRIBMA Governing Committee. Please note that positions are held by individual insurance companies and not carrier groups; no more than one member of the same holding company system may serve on the Governing Committee.

The 2023-2024 term for the Governing Committee members will begin on June 1, 2023 following election at the Annual Meeting; and each newly elected member is expected to participate in the Governing Committee meeting which will be held immediately following adjournment of the Annual Meeting.

If you are interested in having your company considered for membership on the Governing Committee for the 2023-2024 term, please complete and return the attached form, including the identity of whom you wish to designate as the member representative. Governing Committee representatives must hold an executive, officer or senior level management position with the entity they represent; have a comprehensive knowledge of the Massachusetts workers' compensation insurance industry with at least five (5) years of experience in the field of workers' compensation; and have authority to make strategic decisions that affect all WCRIBMA members.
